The goods and services shown here are those we can provide to our customers. You may choose only the items you decide. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Staff.....\$1785.00

Our fee for the funeral director and staff includes, but is not limited to, personnel available 24 hours a day, 365 days a year to respond to the initial request for service; arrangements conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording of vital statistics; preparation and placement of obituary notices; staff assistance prior to, and during the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative cost, and equipment and inventory cost. The fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding of remains.)

Embalming.....\$695.00

Expect in certain cases, law does not require embalming. Embalming may be necessary, however, if you select certain arrangements such as a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Other preparation of the body.....\$150.00

This service includes casketing and additional care of the deceased other than embalming.

Embalming of Autopsy Case or Body Donation Case.....\$150.00

This fee is in addition to the above embalming charge of \$695.00

Refrigeration.....\$35.00 per day

This is for storage of an unembalmed body until services are rendered.

Basic Cremation.....\$1655.00

This charge includes removal of remains, local transportation to crematory, and basic services of staff. This charge does not include any rites or ceremonies.

If you want to arrange for a direct cremation, you can use an alternative container.

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without and outside covering). The containers we provide are cardboard.

1. Allen & Allen accepts cash, personal check, Visa, and MasterCard for full payment of funeral bill. A discount on our funeral services and merchandise will be given to any family which pays the total funeral bill by check, cash or credit card before the funeral service.
2. In cases where the deceased's estate must stand the burden of paying the funeral expenses; we ask that a member of the family pay the funeral bill and file with the estate for reimbursement.
3. We accept assignment of life insurance policies.
