Professional Services

Basic Services of Funeral Director and Staff \$2,735.00
This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Our basic service charge includes, but is not limited to:

- Staff available 24 hours per day/365 days per year, to respond to the initial request for services, conducting the arrangement conference with the family or its representative to determine desired services, and obtaining and recording biographical and statistical information.
- Staff to advise and assist with recommendations for a service which will reflect the unique life, personality and interests of your loved one, and coordinating the arrangements for the service, tribute or gathering.
- Coordination and follow-up with those providing other services, such as hospital, nursing facility, assisted living, home/hospice facility, doctor's office, medical examiner/coroner's office, cemetery, vault company, our crematory, clergy or celebrant, musicians, military, civic organizations, and/or other third parties with regard to involvement with funeral or memorial services and final disposition.
- Preparation, filing, and obtaining certified copies of Death Certificate, and preparation and filing of any necessary notices, authorizations and permits with governmental offices.
- Preparation and transmission of obituary notice to newspaper(s) and/or online media.
- Clerical assistance in preparation of register book, memorial folders, acknowledgement cards, as well as in completion of various forms associated with a service, such as Social Security, Veterans Benefits, and insurance documentation and filing.
- General administration and record keeping, as well as taxes, utilities, maintenance of facilities and equipment, inventory expense, legal and accounting fees, licenses and insurance, and governmental compliance (OSHA, ADA, etc.).
- Dedicated staff who regularly receive continuing education and professional training to meet state and federal licensing requirements.

Care Of Your Loved One

We require the use of licensed personnel to supervise all technical aspects of services provided to those loved ones placed in our care. We take pride in the attention to detail given to every part of the preparation process by our personnel. We want each family to take comfort in knowing that their loved one is being given the dignity and respect they deserve.

Embalming \$ 980.00

Embalming is a chemical process that provides temporary preservation of the body and eliminates certain health hazards. *Embalming may also alleviate an adverse mental picture of a loved one caused by illness, etc.* This procedure is required to be completed by a funeral director/embalmer who is licensed by the State of Georgia. Our fee includes the use of chemical supplies, equipment, emergency equipment for compliance with OSHA regulations for formaldehyde exposure, blood-borne pathogen exposure, work-place safety and disposal of regulated medical waste.

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Cremation \$ 595.00

Infant/Toddler Cremation (through age 3) \$ 75.00

The cremation casket or container that is selected by the family is placed into the care of the staff of our crematory. Once placed into the cremation chamber, intense heat is applied until the cremation casket or container, and its contents, are reduced to ashes and small fragments. The cremated remains are then placed in a processor and subjected to a mechanical process, causing them to be reduced to a size which will allow them to be placed into an urn or container which has been selected by the family. Final disposition or final memorialization may then be completed according to the family’s wishes.

Other Preparation of the Deceased:

Cosmetology, Dressing and Casketing \$ 295.00

- Includes sanitary bandaging or wrapping, dressing, complexion restoration and applying cosmetics, casketing, positioning and all procedures necessary for viewing (of) a properly embalmed body.

Sanitary Care for an Unembalmed Body \$ 980.00

(for viewing other than for purposes of identification)

- Includes hygienic washing and disinfection of an unembalmed body, using OSHA Regulations for universal precautions for blood-borne pathogens, cosmetology, dressing, casketing and any other procedures necessary for viewing prior to burial or cremation. Includes refrigeration and sheltering for 48 hours.

Minimal Care for Identification \$ 225.00

- Includes minimal disinfection of deceased, using OSHA Regulations for universal precautions for blood-borne pathogens.

Preparation of Body for Viewing when Received from Another Funeral Home \$ 295.00

- Includes any or all of the following: Removing your loved one (deceased) from shipping container, additional preservation procedures and/or hygienic bandaging, dressing, application or reapplication of cosmetics, repositioning in casket.

Additional Procedures for Autopsied Remains, Organ/Bone Donors \$ 295.00

- Additional charge for sanitary preparation, materials and equipment for autopsied remains or organ/bone donations.

Refrigeration \$ 50.00 per day

- If the unembalmed remains are to be held at the funeral home for any reason beyond the initial 48-hour period within which a funeral service or cremation is normally planned, this charge will be applied.
