Our charges include funeral counseling, necessary arrangements, recording vital statistics, securing permits, filing and obtaining death certificates and other forms and claims, preparation of necessary notices, and coordination of service plans with parties involved in the final disposition of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.

EMBALMING

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

PAYMENT POLICY

So that we have a complete understanding of the needs of families we serve, we accept the following methods of payment for funeral services and merchandise selected:

1. <u>Cash</u> payment at the time funeral arrangements are made.

2. Personal or Cashiers Check, Visa, MasterCard, Discover or American Express.

3. Assignment of a <u>verifiable life insurance</u> policy in an amount equal to the total cost of the funeral purchase agreement.

4. In the case where a deceased's estate must be responsible for paying funeral expenses, we ask that a <u>member of the family pay funeral expenses</u> and file their claim for reimbursement with the decedent's estate.

5. When more than one member of a family will share in payment of the total funeral bill, we ask that a designated member sign the funeral purchase agreement and be <u>FULLY</u> responsible for payment of the funeral bill. Individual family members may then reimburse the responsible party.

6. <u>The total amount of CASH ADVANCE ITEMS is due in full at the time</u> <u>arrangements are made</u>.

Please advise the Funeral Director assisting your family of the payment method you would prefer. <u>Full payment or a suitable method of financing is expected</u> at the time funeral arrangements are made.

In all cases where the total payment has not been received within 30 days, a late payment fee will be charged at the rate of 16% per annum on the unpaid balance.

The \$255.00 Social Security Death Benefit is NOT paid directly to the funeral home, and is issued only to a spouse or minor child.
