**GENERAL PRICE LIST**

These prices are effective as of June 4, 2018, but are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may change only the items you desire. However, any funeral arrangements you select will include for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**Basic Services of Funeral Director and Staff and Proportionate Share of Overhead Costs ..... \$ 2285.00**

This fee will be added to the total cost of the traditional funeral arrangements or memorial services you select. This fee includes but is not limited to, staff available 24 hours a day to respond to initial request for services, conference with the family or its representative and advise to determine desired services and to obtain vital statistical information for required documents; sheltering of remains; coordinating the desired funeral service plans with clergy, cemetery, crematory and or other third parties; the preparation and filing of all necessary notices, authorizations and permits with governmental offices; follow up attention also to related details connected to the service. In addition, this fee includes a proportionate share of our basic overhead costs such as; compliance with infectious waste management regulations and employee safety regulations mandated by government agencies; general administration and record keeping.

**Limited Services of Funeral Director and Staff and Proportionate Share of Overhead Costs ..... \$ 1435.00**

This fee is included in our charges for direct cremations, and direct burials. This fee includes but is not limited to, staff available 24 hours a day to respond to initial request for services, conference with the family or its representative and advise to determine desired services and to obtain vital statistical information for required documents; sheltering of remains; coordinating the desired funeral service plans with clergy, cemetery, crematory and or other third parties; the preparation and filing of all necessary notices, authorizations and permits with governmental offices; follow up attention also to related details connected to the service. In addition, this fee includes a proportionate share of our basic overhead costs.

**Limited Services of Funeral Director and Staff and Proportionate Share of Overhead Costs ..... \$ 1085.00**

This fee includes but is not limited to, staff available 24 hours a day to respond to initial request for services, conference with the family or its representative to obtain vital statistical information for required documents; sheltering of remains; coordinating with the cemetery, crematory and or other third parties; the preparation and filing of all necessary notices, authorizations and permits with governmental offices. In addition, this fee includes a proportionate share of our basic overhead costs.

**EMBALMING: \$ 715.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as funeral with a viewing. If you do not want embalming you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME: \$2,780.00**

This charge includes removal of remains, embalming, necessary services of staff, necessary authorizations, minimum shipping container, and local transportation to airport.

This charge does not include visitation, rites or ceremonies.  
(without any rites or ceremonies at the funeral home, graveside or elsewhere)

**RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME: \$1,705.00**

This charge includes picking up remains from airport, care of remains, use of facilities and services of staff.  
(without any rites or ceremonies at the funeral home, graveside or elsewhere)

**DIRECT CREMATION: \$2,600.00**

If you want to arrange cremation, you can use an unfinished wood box or an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or compositions materials (without an outside covering)

The container we provide is a heavy cardboard.

The charge for direct cremation includes, basic services of staff, removal of remains, local transportation to crematory, necessary authorizations. This charge does not include the use of facilities and staff for visitations or ceremony, public or private:

**IMMEDIATE BURIAL: \$ 2,500.00**

Our charges for immediate burial (without embalming or any rites or ceremonies at the funeral home, graveside or elsewhere) include: Removal of remains, sanitary care of remains, transportation to cemetery and minimum services of staff. Casket, Opening and Closing of grave and Cemetery charges are not included.

**WEEKEND AND SERVICES CHARGES**

There will be a \$300.00 charge for burial and or vault service scheduled after 3:00pm Monday thru Friday. An additional \$350.00 burial and or vault service scheduled on Saturday or Sunday scheduled before 4:00pm. There will be an additional charge of \$500.00 for burial and or vault service scheduled Sunday 4:00pm or later, Monday thru Sunday. This cost is charged by the company that provides us with opening/closing of graves, burial vaults, grave set up i.e. (tents, chairs, etc.), and is not a charge of Evans Funeral Home.
