

Direct Cremation.....for a direct cremation without any attendant rites or ceremonies includes removal of remains, local transportation to crematory, necessary services of funeral director and staff and authorizations. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering all such containers must meet any applicable state or crematory requirements

INTRODUCTION

This General Price List has been prepared in compliance with the Federal Trade Commission Funeral Rule. The FTC Funeral Rule became effective on April 30, 1984 and was revised in 1993. The revised FTC Funeral Rule became effective on July 19, 1994.

The FTC Funeral Rule requires funeral homes to provide consumers accurate, itemized pricing information and to make various other disclosures about funeral goods and services. In addition, the FTC Funeral Rule prohibits funeral homes from:

- Misrepresenting legal, crematory and cemetery requirements.
- Embalming for a fee without permission.
- Requiring the purchase of a casket for direct cremation.
- Charging casket handling fees for receiving casket from other sources.
- Engaging in other deceptive or unfair practices.

This General Price List available to our clients and other consumers, for their retention, as a part of our compliance with all local, state and federal regulations.

Goolsby Mortuary will gladly accept caskets / funeral merchandise from outside providers, however any discounts given will be voided. Please refer to itemized price list.

The goods and services shown are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our Basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing in the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff and Overhead.....\$1,695.00
 Our services includes conducting the arrangement conference; planning and filing of necessary notices; obtaining necessary authorization and permits; coordinating with the cemetery, crematory or other third parties. In addition, this fee includes a proportionate share of our overhead cost.

This fee for our basic service basic service and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burial and forwarding or receiving remains.)

Embalming.....\$995.00
 Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it such as direct cremation or immediate burial.
