If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers, newspaper notices, programs, etc. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected. (We charge you for our services in buying these items.) Services marked with an asterisk (*) are non-declinable.

SERVICES OF THE FUNERAL DIRECTOR. STAFF

& OVERHEAD.....\$2,995.00 Our basic fees for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party: arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during and following the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs. This fee for our basic service and overhead will be added to the total cost of the funeral arrangement you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

BODY PREPARATION

Embalming......\$995.00 Except in certain special cases, embalming is not required by law. Embalming may be necessary; however, if you select certain funeral arrangements, such as a funeral with a viewing ceremony. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to

pay for it, such as a direct cremation or immediate burial.
