Payment Policy

We are not able to finance funerals so listed below are our accepted methods of payment.

Cash, Check, Visa, MasterCard, Discover, Fully funded funeral plan,

Bank approved financing with your local bank, or Assignable Insurance Policy

Depending on the type of services you select, it may be necessary for you to pay all or a portion of funeral charges before services are performed.

It is not our policy to receive payment for funeral expenses from the settlement of an estate. We respectfully request that a family member pay the funeral bill in full, and the funeral home will provide all necessary documentation for the family member to be reimbursed from the estate.

Insurance assignment is available for those families wishing to pay funeral expenses from the proceeds of a valid insurance policy. Policy verification must be obtained before policy funds will be accepted as payment. If the policy amount is less than the amount of funeral expenses, we respectfully request the family pay the difference prior to the policy proceeds being received. Even in insurance assignment situations, it is necessary for some funds to be paid up front. In order for you to avoid paying out-of-pocket expenses, Henry Funeral Home uses a third party assignment company that will go ahead and pay the charges on your behalf. This company charges a 3.5% assignment fee that will be computed on the total assigned amount and will be added to your funeral statement. We cannot accept policies that are less than two years old and in the contestable period or policies where the Estate is the beneficiary.
