Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during, and following the funeral, e. g. cemetery, crematory, and others. Also included in this charge are proportionate share of operating costs including but not limited to: taxes, licenses, insurance, maintenance, utility expenses, secretarial and administrative costs, equipment and inventory expenses and governmental compliance (FTC and OSHA Requirements).

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select.

EMBALMING..... \$ 975.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Embalming is a chemical process, which provides temporary preservation of the body and eliminates certain health hazards. A person licensed by this state must complete this procedure.

This charge also includes disposal of regulated medical waste and compliance with state and federal OSHA bloodborne pathogen requirements.

(Our firm does not have refrigeration facilities, therefore, in the interest of the health of our staff, any remains that must be held at our funeral home more than 24 hours following death and prior to cremation will be embalmed and the regular charge for embalming will be made.)
