Our fee for the basic services of funeral director and staff include, but is not limited to, personal available 24 hours a day, 365 days a year to respond to initial request for service; an arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; shelter of remains and coordination with those providing other portions of the funeral, e.g. cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charge for direct cremations, immediate burials and forwarding or receiving remains,)

This list may not include prices for items you select, such as Cemetery charges or Crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items. This basic service is non-declinable. Prices subject to change without notice. Effective June 12, 2016.

EMBALMING - \$795
