Introduction

This General Price List has been prepared in compliance with the Federal Trade Commission Funeral Rule. The FTC Funeral Rule became effective on April 30, 1984 and was revised in 1983. The revised FTC Funeral Rule became effective on July 19, 1994.

The FTC Funeral Rule requires funeral homes to provide consumers access to detailed, itemized pricing information prior to purchase decisions and to make various other disclosures about funeral goods and services. In addition, the FTC Funeral Rule prohibits funeral homes from:

- Misrepresenting legal, crematory and cemetery requirements.
- Embalming for a fee without permission.
- Requiring the purchase of a casket for direct cremation.
- Requiring consumers to purchase certain funeral goods as a condition for purchasing other goods and services.
- Charging casket handling fees for receiving caskets from other sources.
- Engaging in other deceptive or unfair practices.

Tri-Cities Funeral Home, Inc. operates in full compliance with the Federal Trade Commission Funeral Rule and makes this General Price List available to our clients and other consumers, for their retention, as a part of our policy of full compliance with all local, state and federal regulations.

Statement of Funeral Goods and Services:

The goods and services shown are those we can provide to our families. You may choose only the items you desire. However, any arrangements you select will include a charge for our basic services and overhead. If legal or other regulatory requirements mean you must buy any item you did not specifically ask for, we will explain the reason in writing on the statement provided which describes the funeral goods and services selected.

Basic Services of the Funeral Director and staff: \$2,650.00 The fee for the services of the funeral director and staff includes, but is

not limited to:

- Personnel available 24 hours a day, 365 days a year, to respond to the initial request for service;
- Arrangements conference with the family or responsible party;
- Preparation and filing of necessary authorization and/or permits;
- Recording of vital statistics;
- Preparation and placement of obituary newspaper notices;
- Staff assistance prior to, during, and following the funeral, including coordination with those providing other portions of the funeral, {e.g. the cemetery, crematory, etc.};
- · Overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative cost, and equipment and inventory cost.

Embalming: (Non Autopsy Cases)

Except in certain special situations, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right you choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Forwarding Remains To Another Funeral Home:

Cremation Services

Cremation Services: (Direct Cremation)

Our charges for a direct cremation without any attendant rites or ceremonies includes removal of remains, necessary services of staff for authorizations and cremation charges. Our crematory requires the human remains be placed in a minimum alternative cremation container to enable us to place the remains into the cremation chamber for cremation. Alternative containers encase the remains and can be made of materials like heavy corrugated cardboard, fiberboard or composition materials.

Direct Cremation with Container Provided by the Purchaser: \$1,195.00 All containers provided must meet any applicable state or crematory requirements.

Direct Cremation with Private Family Viewing: \$2,420.00

All services included in direct cremation, as well as bathing and dressing of the deceased, and 1 hour family viewing. This does not include a container for viewing.

Traditional Service with Cremation: (in addition to cost of casket) \$5,370.00 This charge includes removal of remains, services of director and staff, preparation/embalming, dressing and cosmetizing, use of the facilities for one day visitation, church or chapel service, necessary automotive equipment and cremation charges.

Immediate Burial Services:
