OTHER SERVICES

Certified Death Certificates: The price of death certificates vary from state to state and in some cases from county to county.

In the State of Georgia-Certified Death Certificates are \$25.00 for the first and \$5.00 for each additional certified copy.

In the State of Tennessee-Certified Death Certificates are \$15.00 each.

Death certificates are required to file insurance, handle bank accounts, credit card accounts, most all legal transactions, etc... We will ask how many certificates that you may need and get them prepared for you. Most families have insurance to pay for the funeral expenses and we accept current insurance policies for assignments of the funeral expenses incurred only at the funeral home (we will not be responsible for outside assignments such as cemetery expenses, florist expenses and any other charges we do not have control of at the time of assignment of proceeds.) Insurance assignments usually take 45 to 90 days from the date of death for payment.

Therefore, we do not release certified or copies of the death certificates until funeral expenses are paid in full.

If you choose to pay the at need funeral expenses in full by means of cash, verified check or cashier's check you will receive a 5% discount. All other methods of payment such as credit cards, will be subject to the total of the Statement of Funeral Goods and Services Selected.

Receiving A Deceased Person from another Funeral Home: -----\$ 2,890.00
