SERVICES FOR THE FUNERAL DIRECTOR AND STAFF:

Fee for service of Funeral Director and staff, includes but not limited to, staff to respond for request for service; arrangement consultations with family and or designated responsible party; arrangement of funeral; preparation and filling of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices, staff assistance prior to, during and following the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others.

Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance, utility expenses, secretarial and administrative and equipment and inventory costs.

EMBALMING: \$925.00

Embalming is not required in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.
